<u>Question 1</u>: What kinds of positions are you looking to staff here? <u>Answer to Question 1</u>: Reference DETAILED SPECIFICATIONS, Item 3. Scope of Work, page 17, for a list of the City's current open positions.

<u>Question 2</u>: Are we able to bid on some categories and not others? <u>Answer to Question 2</u>: The intent of this RFP is to seek proposals from qualified staffing Agency(s) for the positions that each Agency can offer with a corresponding hourly rate.

<u>Question 3</u>: What previous spend have you used on temporary staffing services? <u>Answer to Question 3</u>: This is the first time the City has issued a solicitation for staffing services so past history is not available.

<u>Question 8</u>: Tab 3: Where are the positions that we need to price for in the proposal? <u>Answer to Question 8</u>: Reference Answer to Question 1 above.

<u>Question 9</u>: Kindly let us know the spending for the last few years under this sourcing category at the City of Clearwater. Also how many positions are sourced annually through this model. <u>Answer to Question 9</u>: Reference Answer to Question 3.

<u>Question 10</u>: What are your payment terms? <u>Answer to Question 10</u>: The City's standard payment terms are Net 30.
