

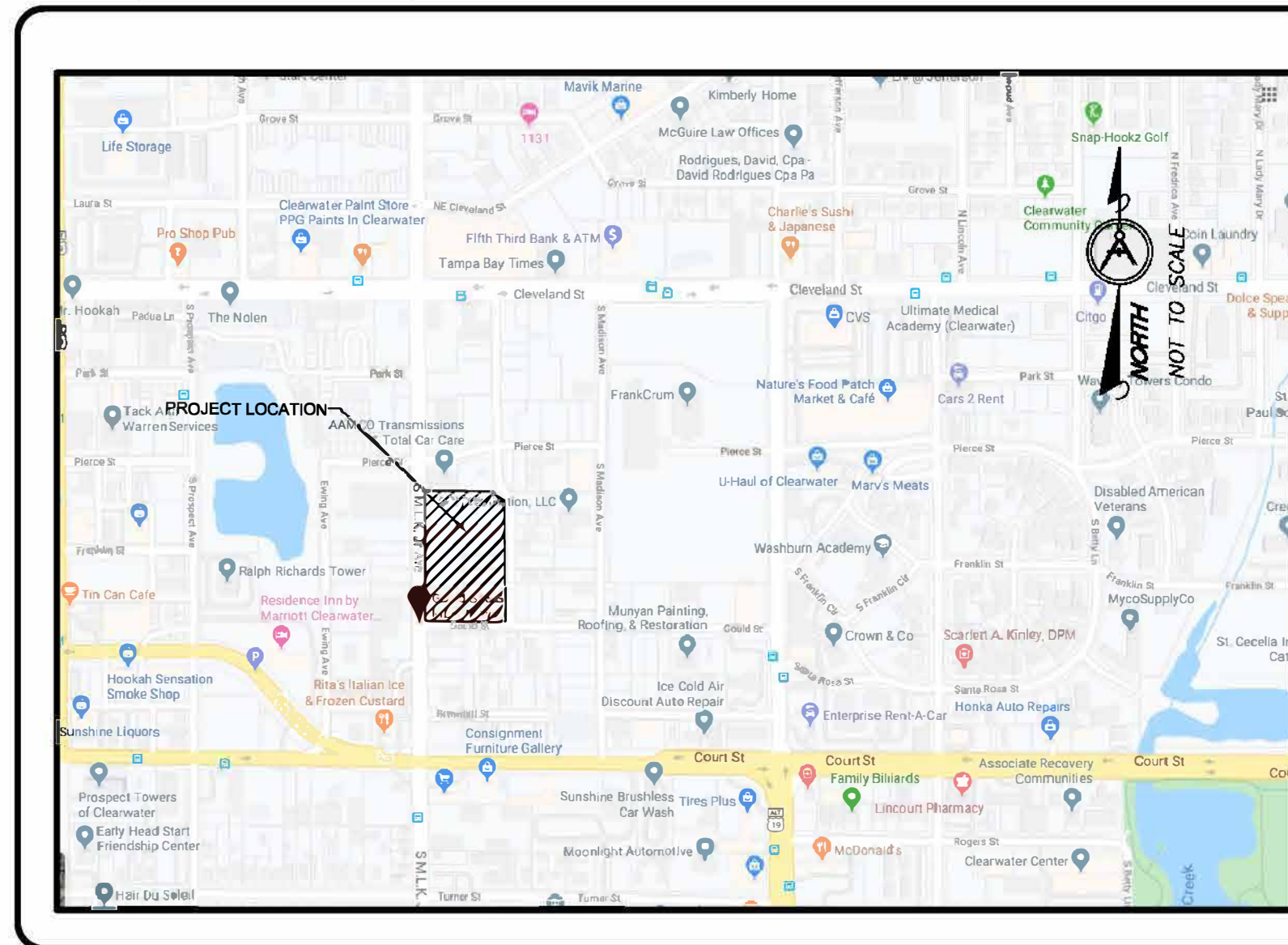
MAP OF SURVEY

SURVEYORS NOTES

- The Survey shown hereon was prepared without the benefit of a Title report.
- For the use of this Survey an Assumed bearing of North 00°03'23" East along the West right of way line of Martin Luther King Jr. Blvd.
- The location of utilities shown hereon are from observed evidence of above ground appurtenances only. The Surveyor was not provided with underground plans to determine the location of any subterranean uses. Some utilities may have been obstructed from view (e.g., debris or vehicles on top of)
- This Survey was conducted for the purpose of a Boundary and Topographic Survey only, and is not intended to delineate the regulatory jurisdiction of any Federal, State, Regional or local Agency, Board, Commission or other similar entity.
- No underground installations or improvements have been located except as noted.
- No instruments of record reflecting Easements, Setbacks, Restrictions, Rights of Way, and or Ownership were furnished to this Surveyor except as shown.
- Fences shown hereon were only located at starting and ending points and may meander between points located. (ownership not determined by this survey)
- All Official Record Books and numbers pertain to the Public Records of Pinellas County, Florida.
- The legal description of this property was obtained from Official Records Book 15246, Page 248.
- No evidence was observed or provided to this Surveyor of any Cemeteries or Burial Grounds existing on this site.
- There was no observable evidence of any earth moving work, building construction or building additions at the time of this Survey.
- There were no observable evidence that this site was used a solid waste dump, sump or sanitary landfill.
- By observed evidence it appears there are no drainage structures, ditches to indicate the property may serve adjoining properties for drainage purposes. (This should be determined by an Engineer)
- Said described property is located within an area having a Zone Designation "X" and by the Flood Insurance Rate Map No. 12103C0108H, with a date of identification of May 17, 2005, which is the current Flood Insurance Rate Map for the community in which said property is situated.
- There was no observable evidence or information provided to this surveyor of any proposed changes in street right of way lines and there was observed evidence of recent street or sidewalk construction or repairs. (West Side of Martin Luther King Jr. BLVD).
- Tree Identification is out of this Surveyors area of expertise and recommends that the client hires and Arborist to obtain the correct species and sizes if Needed.

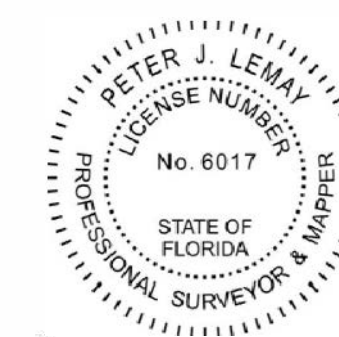
BENCHMARK INFORMATION

Elevation = 29.23' (North American Vertical Datum of 1988)
- TBM # 2: Set "X" Iron rod stamped "LS 6017" on East side of Washington Street.
Elevation = 35.89' (North American Vertical Datum of 1988)
- TBM # 3: Set nail and disc Stamped "LS 6017" located 12' North of the centerline intersection of Gould Street and Washington Street.
Elevation = 43.28' (North American Vertical Datum of 1988)

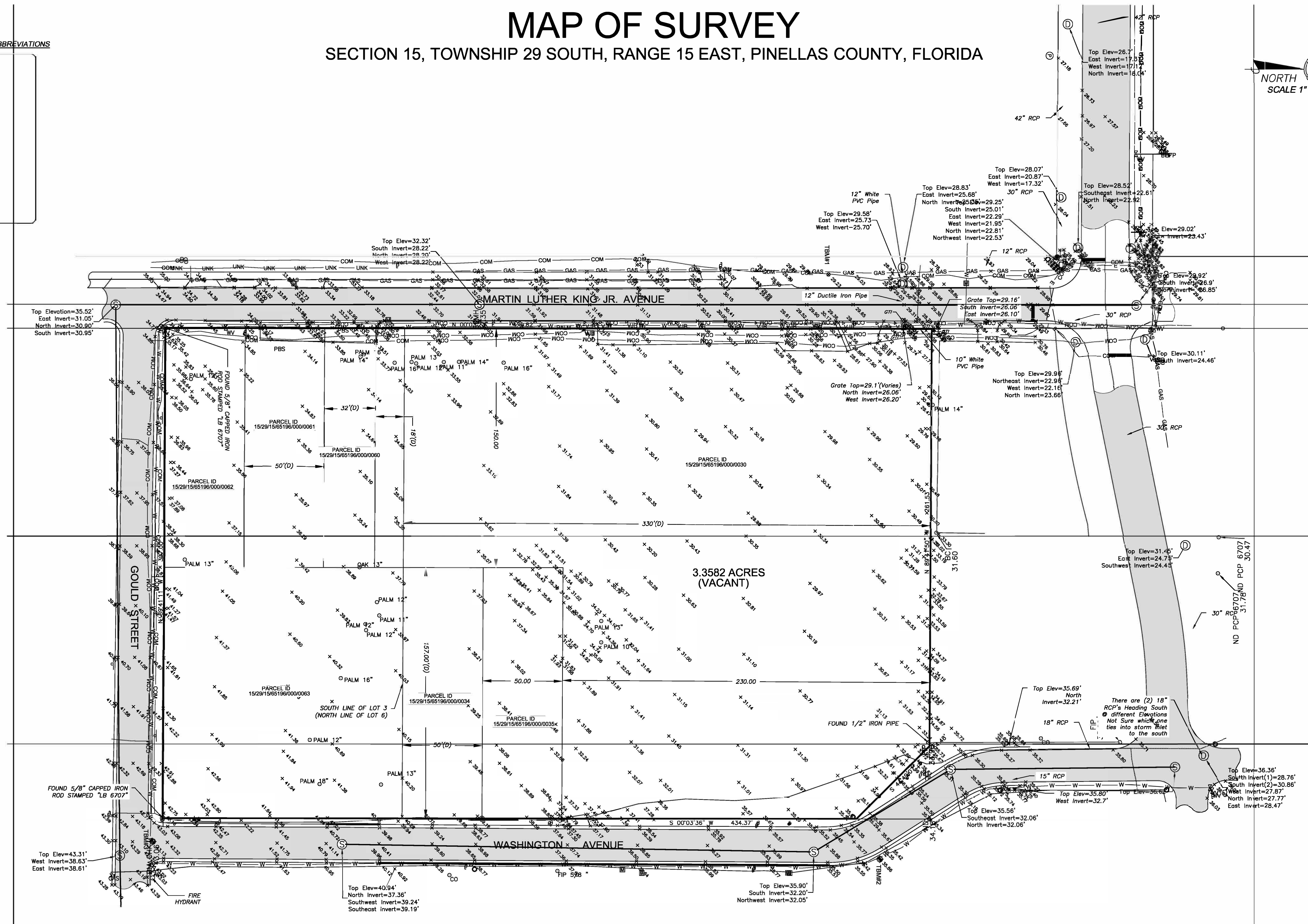
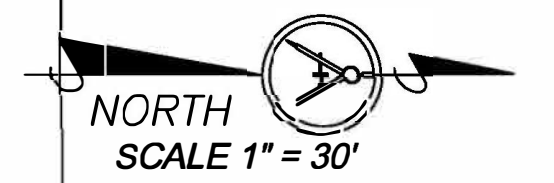
